

## **I. General Information**

### **Cedar Rapids Little Reds Baseball, Inc Car/Cash Raffle 2024 RULES & REGULATIONS**

The Cedar Rapids Little Reds Baseball, Inc (CRLRB), a tax-exempt organization under Section 501(c)(3) of the Internal Revenue Code, is conducting this raffle pursuant to Iowa Code Chapter 99B, to raise funds for ongoing charitable purposes. The Rules and Regulations of the CRLRB raffle are set forth below. By purchasing a raffle ticket, the purchaser agrees to be bound by these rules and regulations. The CRLRB's interpretation and application of the rules and regulations shall be final.

The Grand Prize is a 2025 Chevy Trax valued at \$23,790.

The Grand Prize Drawing will be conducted by the CRLRB on or about December 20, 2024, subject to rescheduling, as more particularly described below. Tickets will not be sold after 11:59 p.m. Central Time on December 16, 2024. Tickets may sell out before that time. Participants need not be present to win.

The IRS has taken the position that amounts paid for chances in raffles, lotteries or similar drawings for valuable prizes are not gifts, and consequently do not qualify as deductible charitable contributions.

All defective or physically altered entry forms will be immediately disqualified by the CRLRB. The CRLRB will attempt to make contact through the information provided at the time of submitting the purchase request.

## **III. How to Purchase:**

An individual can purchase as many tickets as he or she may wish, subject to availability.

Get your tickets today from any Cedar Rapids Reds baseball or softball player. If you do not know any reds players please reach out to [raffletickets@crreds.com](mailto:raffletickets@crreds.com) and we will send a player out.

All entries must include payment by cash, personal check, money order, bank check, cashier's check, electronic check. Iowa law prohibits the use of credit cards for social and charitable gambling. No other refunds are available except at the exclusive discretion of the CRLRB. The CRLRB assumes no responsibility for lost, late, misdirected or non-delivered mail, or any other failure to receive orders or deliver receipts prior to the drawing deadlines.

#### **IV. Selection of Grand Prize Drawing Winner:**

The Grand Prize Winner of the 2024 CRLRB Car Raffle will be announced on or about December 20, 2024 for all eligible raffle tickets. The physical location of draw will be announced at a later date and may be changed without notice at the discretion of the CRLRB. Winner need not be present to win. The Grand Prize Drawing will be streamed live via social media channels to be announced prior to the drawing.

The Grand Prize Winner will be notified as soon as practicable according to the contact information provided to the CRLRB at the time of ticket purchase. If the Winner cannot be located by 5:00 p.m. Central Time on December 22, 2024, after the CRLRB has attempted to contact him or her through the information provided at the time of purchasing the ticket, he or she will be deemed to have forfeited the Grand Prize. Another winner will be selected for the Grand Prize in the same manner.

which begins November 6, 2024 and ends December 20, 2024. Registration does not imply endorsement.
